## POWER OF ATTORNEY

## KNOW ALL PERSONS BY TRESS PRESENTS:

Savings, Gulfport, Mississippi, to:

- 1. Sign, seal and deliver as the act and deed of the RTC any instrument in writing, and to do every other thing necessary and proper for the collection and recovery of any and all monies and properties of every kind and nature we hatsoever for and on behalf of the RTC and to give proper receipts and acquittances in the name and on behalf of the RTC;
  - 2. Release, discharge or assign any and all judgments, deeds of trust or mortgages on real estate or security interests in personal property (including the release and discharge of the same of record in the office of any Chancery Clerk or any other Clerk of Court wherever located where payments on account of the same in redemption or otherwise may have been made by the debtor(s)), and to endorse receipt of such payment upon the records in any appropriate public office;
  - Receipt, collect and give all proper acquittances for any other sums
    of money owing to the RTC for any asset which the above-named may sell or
    dispose of;
  - 4. Execute any and all transfers and assignments as may be necessary to assign any securities or other choses in action;
  - Sign, seal, acknowledge and deliver any and all agreements as shall be deemed necessary or proper by the Specialist in Charge in the care and management of any assets;
  - sign, seel, acknowledge and deliver indemnity agreements and surety bonds in the name of and on behalf of the RTC;
  - sign receipts for the payment of all rents and profits due or to become due on any assets;
  - Execute, acknowledge and deliver deeds of real property in the name of the RTC;

- Extend, postpone, release and satisfy or take such other action regarding any mortgage or deed of trust held in the name of the RTC.
- 10. Execute, acknowledge and deliver in the name of the RTC a power of attorney wherever necessary or required by law to any attorney employed by the RTC:
- 11. Foreclose under any mortgage, deed of trust, security agreement or other lies on either real or personal property, wherever located;
- Do and perform every act necessary for the use, liquidation or collection of any assets in the name of the RTC;
- 13. Sign, seal, acknowledge and deliver any and all documents as may be necessary to settle any action(s) or claim(s) asserted by or against the RTC either as Receiver or in its Corporate capacity; and
- 14. Sign, seel, acknowledge and deliver in the name of RTC a substitution of Trustee under any deed of trust.

This Power of Attorney shall be effective as of July 17, 1990, and shall continue until such time as this Power of Attorney has been terminated by the Board of Directors of the RTC or by any officer of the RTC authorized to do so by the Board of Directors of the RTC.
