Cemetery Deed

KNOW ALL MEN BY THESE PRESENTS: That for and in consideration of Two Thousand and Three Hundred and Fifty ~~and No/100 Dollars~~ (\$ 2,350.00 -----), in hand paid to RIDOUT'S-BROWN-SERVICE INC., a corporation, (hereinafter referred to as "Grantor") by Mr. Douglas T. Arendall -----

(hereinafter referred to as "Grantees" whether one or more), the receipt of which is hereby acknowledged, the said Grantor does by these presents grant, bargain, sell and convey unto the said Grantees, upon the terms, conditions and provisions hereinafter set forth, the use of the following described burial places in Southern Heritage Cemetery, City of Pelham, County of Shelby, State of Alabama, to-wit:

Section: Pelham H, Block: 102, Spaces: 1, 2, 3, and 4 -----

According to the map of said cemetery on file in the office of Grantor.

IT IS EXPRESSLY UNDERSTOOD that said burial places are to be used exclusively for the burial of human remains alone, and are sold and conveyed subject to such supervision, control and regulation by Grantor, its successors and assigns, as is now, or may hereafter be prescribed in the Rules and Regulations of said cemetery which are now in force, and as amended and changed from time to time hereafter, as the same are on file in the office of Grantor and available for inspection upon request. No transfer or assignment of any right or interest acquired by the Grantees herein shall be valid unless and until such transfer is recorded on the books and records of Grantor. The covenants, terms and conditions of this conveyance shall be construed as running with the land and shall bind the Grantees hereto, and their heirs and assigns.

TO HAVE AND TO HOLD to the said Grantees, their heirs and assigns, forever; subject to the restrictions and limitations referred to herein.
