

KEN LOKEY HOMES, INC.  
POWER OF ATTORNEY

This Power of Attorney, made this 15th day of October, 1990, by and between Ken Lokey Homes, Inc., a Texas corporation, duly qualified to do business in the State of Alabama, party of the first part, and BARBARA RICHARDSON, TRUDY HARRIS and SARADEAN RICHARDSON, employees of Ken Lokey Homes, Inc., in Birmingham, Alabama, party of the second part.

WHEREAS, Ken Lokey Homes, Inc., has previously acquired and is record owner of land in Alabama, and may acquire other land in the State of Alabama; and

WHEREAS, by corporate resolutions made, the sole Director of the corporation has authorized the President to give to employees of the corporation power of attorney so that they may act as Attorneys-in-fact for the Corporation pursuant to said resolutions.

NOW, THEREFORE, the party of the first part, pursuant to said resolution, does hereby name, designate and appoint BARBARA RICHARDSON as its Attorney-in-fact, to act for its Alabama Division, and does hereby authorize, ratify and confirm all that said Attorney-in-fact may lawfully do, or have caused to be done in accordance with the said resolutions.

Ken Lokey Homes, Inc., hereby authorizes such Attorney-in-fact, on behalf of said corporation to sign, execute, enter into and deliver contracts, agreements, deeds or other necessary documents, instruments or papers for the sale by Ken Lokey Homes, Inc. of finished homes or homes to be finished (together in each instance with the finished lots for the home) provided, however that except for the sale of any lot together with such home, no such employee shall have any power or authority to sell any land whatsoever.
