KNOW ALL MEN BY THESE PRESENTS, THAT:

WHEREAS, heretofore on, to-wit: March 6, 1986, Jeanette C. Hammons, a single person, mortgagor, executed a certain mortgage to MortgageAmerica, Inc. which said mortgage is recorded in Book 64, page 892 and rerecorded in Book 157, page 833, in the Office of the Judge of Probate of Shelby County, Alabama, said mortgage being assumed by Robert M.
