That in consideration of SIXTY NINE THOUSAND NINE HUNDRED & NO/100— (\$69,900.00) DOLLARS to the undersigned grantor or grantors in hand paid by the GRANTEES herein, the receipt whereof is acknowledged, we, Steven Lee Savage and wife, Laura Mann Savage (herein referred to as grantors), do grant, bargain, sell and convey unto Eric C. Gilbert and wife, Donna S. Gilbert (herein referred to as GRANTEES) for and during their joint lives and upon the death of either of them, then to the survivor of them in fee simple, together with every contingent remainder and right of reversion, the following described real estate, situated in Shelby County, Alabama, to-wit:
