That in consideration of ONE HUNDRED EIGHTEEN THOUSAND NINE HUNDRED AND NO/100ths (\$118,900.00) DOLLARS to the undersigned grantor or grantors in hand paid by the GRANTEES herein, the receipt whereof is acknowledged, we, Alva Battle, d/b/a B & S Construction, Co. (herein referred to as grantors) do grant, bargain, sell and convey unto
