

PARTIAL RELEASE

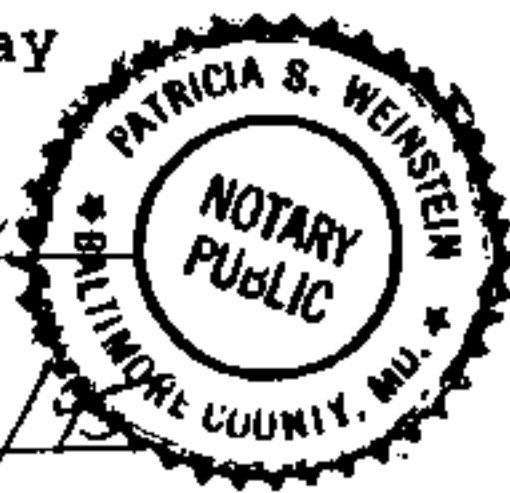
