Including replacements and additions the table to be and remain a part of the real estate covered by this Mortgage; and all of the foregoing are hereinafter referred to as "Real Estate" and shall be bonveyed by this Mortgage.

The Mongagor covenants with the Mongagoe that the Mongagor is lawfully seized in fee simple of the Real Estate and has a good right to self and convey the Real Estate as alloresaid; that the Real Estate is free of all encumbrances, except as stated herein and the Mortgagor will warrant and forever defend the fittle to the Real Estate unto the Mortgagoe against the lewful claims of all persons. except as otherwise herein provided

Mortgagor agrees that, in the event that any provision or clause of this Mortgage or the Credit Agreement conflict with applicable law, such conflict shall not affect any other provisions of this Mortgage or the Credit Agreement which can be given effect. It is agreed that the provisions of the Mortgage and the Credit Agreement are severable and that, if one or more of the provisions contained in this Mortgage or in the Credit Agreement shall for any reason be held to be invalid, illegal, or unenforceable in any respect, such invalidity, illegality, or unenforceability shall not affect any other provision hereof: this Mortgage shall be construed as if such invalid. illegal or unenforceable provision had never been contained herein. The Mortgagor agrees to keep the Real Estate and all Improvements located thereon in good repair and further agrees not to commit waste or permit impairment or deterioration of the Real Estate, and at all times to maintain such improvements in as good condition as they are, reasonable wast and teat excepted.

Notwithstanding any other provision of this Mortgage or the Credit Agreement, this Mortgage shall be deemed to be in default and the Debt shall become immediately due and payable, at the option of the Mortgages, upon the sale, lease, transfer or mortgage by the Mortgagor of all or any part of, or all or any interest in the Real Estate, including transfer of an interest by contract to self.

The Mortgagor agrees that no delay or failure of the Mortgagee to exercise any option to declare the Debt due and payable shall be deemed a waiver of the Mortgagee's right to exercise such ontion, either as to any past or present default, and it is agreed that no terms or conditions contained in this Mortgage may be waived, aftered or changed except by a written instrument signed by the Mortgagor and signed on behalf of the Morigagee by one of its duly authorized representatives.

After default on the part of the Mortgager, the Mortgagee, upon bill filled or other proper legal proceedings being commenced for the foreclosure of this Mortgage, shall be entitled to the appointment by any competent court, without notice to any party, of a receiver for the rents, issues and profits of the Real Estate, with power to lease and control the Real Estate, and with such other powers as may be deemed necessary.

UPON CONDITION, HOWEVER, that if the Mortgagor pays the Debt in full (which debt includes (s) all advances heretofore or from time to time hereafter made by the Mortgages to the Borrower under the Credit Agreement or any extension or renewal thereof, up to a maximum principal amount at any one time outstanding not exceeding the Credit Limit: (b) all finance charges payable from time to time on said advances, or any part thereof; (c) all other charges, costs and expenses now or hererafter owing by the Borrower to the Mortgagee pursuant to the Credit Agreement, or any extension or renewal thereof; (d) all other indebtedness, obligations and liabilities now or hereafter owing by the Borrower to the Mongagee pursuant to the Credit Agreement, or any extension or renewal thereof; and (e) all advances by the Mortgages under the terms of this Mortgages and the Mortgages is reimbursed for any amounts the Mortgages has paid in payment of Lions and insurance premiums or any prior mortgages, and interest thereon, and the Mortgagor fulfills all of the Mortgagor's obligations under this Mortgage, then this conveyance shall be null and void.
