TRACT NO. 2 : Commence at the Northeast corner of the NW $\frac{1}{4}$ of NW $\frac{1}{4}$, Section 17, Township 20 South, Range 1 East for the point of beginning; thence run Southerly along the East boundary line of said NW $\frac{1}{4}$ of NW $\frac{1}{4}$ a distance of 713.53 feet to a point; thence turn an angle of 46° 47' 24 " to the right and run Southwesterly a distance of 1748.98 feet to a point; thence turn an angle of 133° 13' 40" to the right and run Northerly a distance of 713.74 feet to a point; thence turn an angle of 46° 46' 20" to the right and run Northeasterly a distance of 1748.68 feet to the point of beginning. Said tract of land is lying in the NW $\frac{1}{4}$ of NW $\frac{1}{4}$, and SW $\frac{1}{4}$ of NW $\frac{1}{4}$, Section 17, Township 20 South, Range 1 East and contains 20.879 acres.
