ARTICLES OF INCORPORATION

ARTICLE ONE

NAME

The name of the corporation is QUALITY REPAIR & MAINTENANCE, INC.

ARTICLE TWO

DURATION

The term of existence of the corporation is perpetual.

ARTICLE THREE

PURPOSE

The purposes for which the corporation is organized are: to engage in any lawful business or activities related to the stated purpose, and to engage in any lawful act or activity for which corporations may be organized under the Alabama Business Corporation Act.

ARTICLE FIVE
CAPITAL STOCK

The total number of shares that the corporation has authority to issue is 100 shares, all of which shall be common shares with a par value of \$20.00 per share. There shall be no more than two (2) shareholders. Stock shall be issued and transferrable only to natural persons who are not non-resident aliens.

No share-holder of this corporation shall have any pre-emptive or preferred right to purchase any proportion of any stock or securities of this corporation that may be issued or sold by the corporation.

ARTICLE SIX

The number of directors constituting the initial Board of Directors shall be the same number as the number of persons listed in this Article Six. 



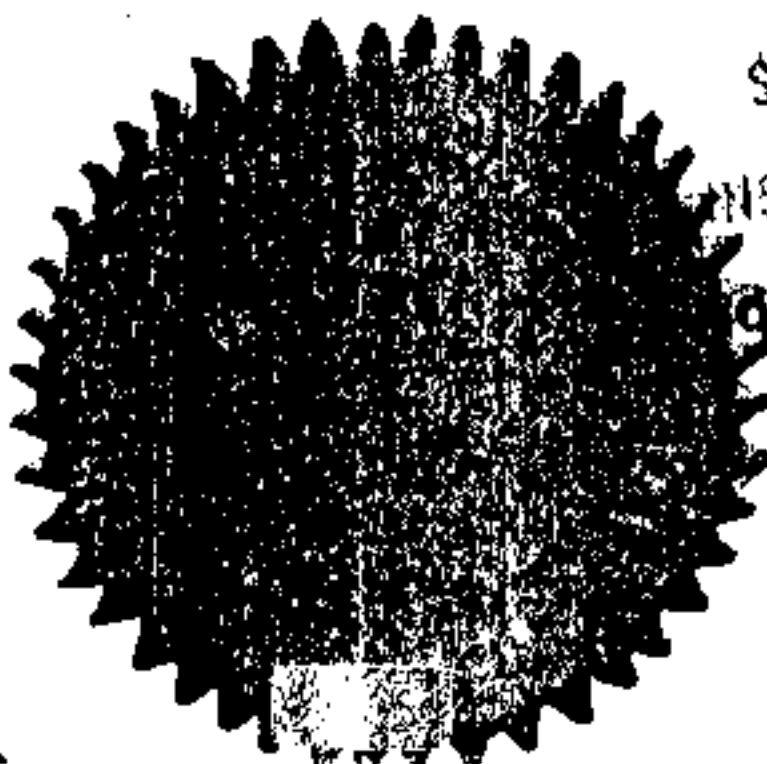
