ARTICLES OF INCORPORATION

hereby file the following Articles of Incorporation, pursuant
to the laws of the State of Alabama, and the undersigned
Incorporators do hereby make and subscribe their names to
these Articles.

ARTICLE I:

The name of the corporation shall be Concept Binding Co, Inc.

ARTICLE II: OBJECTS

ARTICLE III: PRINCIPAL OFFICE AND REGISTERED AGENT

The principal office of the corporation shall be in Pelham,
Alabama, at 804 Creekview Drive.

The initial registered agent of the corporation authorized
to receive service of process is Frank J. Gattina whose
address is 804 Creekview Drive at Pelham, Alabama

ARTICLE IV: AUTHORIZED CAPITAL STOCK

The total authorized capital stock shall be One Hundred
Dollars (\$100.00) consisting of 100 shares of common stock


