the South half of the North West quarter, the South West quarter of the North East quarter, and the North West quarter of the South East quarter of Section twelve, in Township twenty-two, of Range four, West, in the District of Lands subject to sale at Tuscaloosa, Alabama, containing One hundred, and Sixty acres,

according to the official plat of the Survey of the said Lands, returned to the General Land Office by the SURVEYOR GENERAL, which said tracts have been purchased by the said Calvin M. Harris.

Calvin M. Harris,

and to his heirs and assigns forever.
