AMENDMENT TO MORTGAGE

This Amendment to Mortgage entered into this 25th day of March, 1991 on behalf of Strain Construction, Inc. (the "Mortgagor") in favor of National Bank of Commerce of Birmingham (the "Bank").

- A. Page 1 of the Mortgage is hereby modified in part to read as follows: Strain Construction, Inc. is or will be justly indebted to the Mortgagee in the amount of Twenty Thousand and no/100 (\$20,000.00) as evidenced by that certain promissory note dated March 25, 1991 and which has a final maturity date of March 25, 1993.


