AMENDMENT TO MORTGAGE

This Amendment to Mortgage entered into this 25th day of March, 1991 on behalf of Strain Construction, Inc. (the "Mortgagor") in favor of National Bank of Commerce of Birmingham (the "Bank").

Recitals

A. By Real Estate Mortgage recorded in the Office of the Judge of Probate of Jefferson County, Alabama, at Real Volume 143, page 446, the Mortgagor granted a mortgage to the Bank to secure indebtedness as evidenced by a promissory note dated July 24, 1987, in name of Strain Construction, Inc., in the original principal amount of 71,150.00 (the "Mortgage").

B. The Mortgagor has requested the Bank to extend further credit to the Mortgagor, and the Bank has agreed to extend further credit to the Mortgagor on the condition, among others, that the Mortgagor execute and deliver this Amendment to Mortgage.

C. The outstanding principal balance of the above-described indebtedness is \$5,182.99.

D. The Bank desires to add additional collateral to secure said indebtedness referenced above, more specifically the following:

Lot 67, according to the survey of Navajo Hills, 9th Sector, as recorded in Map Book 10, Page 84, in the Probate Office of Shelby County, Alabama.

Agreement

Wherefore, premises considered, the parties hereby agree as follows:

1. Page 1 of the Mortgage is hereby modified in part to read as follows: Strain Construction, Inc. is or will be justly indebted to the Mortgagee in the amount of Twenty Thousand and no/100 (\$20,000.00) as evidenced by that certain promissory note dated March 25, 1991 and which has a final maturity date of March 25, 1993.

THIS AMENDMENT TO MORTGAGE SECURES ADDITIONAL INDEBTEDNESS OF \$14,817.01.

2. Page 1 of the Mortgage is hereby modified in part to add the above-described real estate.

3. Except as herein modified, the Mortgage shall remain in full force and effect.
