KNOW ALL MEN BY THESE PRESENTS,

That in consideration of One and NO/100's Dollars (\$1.00) and other good and valuable consideration to the undersigned grantor or grantors in hand paid by the GRANTEES herein, the receipt whereof is acknowledged, I, Robert Cecil Dyer, Sr., a widowed man (herein referred to as grantor) do grant, bargain, sell and convey unto Robert Cecil Dyer, Sr., and Judy D. Edwards, an unmarried woman (herein referred to as GRANTEES) for and during their joint lives and upon the death of either of them, then to the survivor of them in fee simple, together with every contingent remainder and right of reversion, the following described real estate situated in Shelby County, Alabama to-wit:

TRACT NO. 3 according to the survey of W.M. Varnon, Registered Land Surveyor 9324, dated April 26, 1985: Begin at the Northwest corner of the Northeast quarter of Section 28, Township 19 South, Range 2 East, Shelby County, Alabama; Thence Southerly along the West line of said quarter section 1226.41 feet, more or less, to the centerline of Southern Railway right-of-way, said point being the point of beginning; Thence continue Southerly along said West line 447.00 feet; Thence left 90 degrees 34 minutes in an Easterly direction 1616.50 feet, more or less, to the West right-of-way of a public road; Thence left 97 degrees 30 minutes in a Northerly direction along said right-of-way 242.00 feet; Thence left 7 degrees 00 minutes in a Northerly direction along said right-of-way 350.00 feet; Thence left 100 degrees 00 minutes in a Southwesterly direction 209.00 feet; Thence right 100 degrees 00 minutes in a Northerly direction 384.00 feet to said centerline of railway right-of-way; Thence left 100 degrees 00 minutes in a southwesterly direction along said centerline 1391.63 feet, more or less, to the point of beginning.
