ARTICLES OF INCORPORATION

FIRST: The name of the corporation is Cahaba Valley Home Builders, Inc.

SECOND: The period of its duration is perpetual.

THIRD: The purposes for which the corporation is organized are:

- 1. To engage in the construction business including, but not limited to, residential home construction, commercial construction, industrial construction and such other construction projects as the corporation may from time to time deem appropriate. In furtherance of the above, the incorporation shall be authorized to lease, purchase, and sell real property. The corporation shall be authorized to do all things necessary and incidental to the operation of a construction business.
- 2. FIFTH: Provisions for the regulation of the internal affairs of the corporation are provided for in the by-laws and regulations of the corporation that the stockholders have the authority to adopt as they deem necessary or expedient and each share of stock shall have one (1) vote at a meeting of the stockholder and may be voted by a stockholder of record in person or by proxy.
