CERTIFICATE OF FIRST AMENDMENT
TO
AGREEMENT AND CERTIFICATE OF LIMITED PARTNERSHIP
OF
CSR, LTD.
(A Limited Partnership)

The undersigned, Gwendolyn Brown Massey, Administratrix of the Estate of James Elmer Massey, deceased (the "Assignor"), Central Steel Service, Inc., an Alabama corporation (the "Assignee"), CSR, Ltd. (the "Partnership"), an Alabama limited partnership organized and existing pursuant to an Agreement and Certificate of Limited Partnership (the "Partnership Agreement") recorded in Book 29, Page 891, in the Office of the Judge of Probate of Shelby County, Alabama, and the remaining undersigned general and limited partners of the Partnership, do hereby agree to the following amendments to the Partnership Agreement:

ARTICLE I

The name of the limited partnership is:

CSR, LTD.

ARTICLE II

The date of filing of the Partnership Agreement was March 11, 1986.

ARTICLE III

Assignor, in accordance with paragraph 13.4 of the Partnership Agreement, has sold and assigned to Assignee the twenty percent (20%) limited partnership interest in the Partnership heretofore owned by the decedent, James Elmer Massey.

NOW, THEREFORE, the amendments to the Partnership Agreement are as follows:

1. Paragraph 5.1 of Article V of the Partnership Agreement is hereby amended to read as follows:
