My name is Charles Boles. I am over 21 years of age  
and have been a resident of Shelby County, Alabama for the past 20 years.  
I have been familiar with the possession and claim of ownership of the  
following described land in Shelby County, Alabama, for the last 20 years  
or more, and know the uses to which this land has been put over the years  
by the owners. The land is described as follows: The North 590 feet of

To my knowledge the above described land has been in open,

land to Mead Land Services, Inc. on May 1, 1974 (Real Volume 287, page 78).  
Mead Land Services, Inc. conveyed this tract to Carmen R. Crim, Sr. and  
wife, Helen L. Crim August 15, 1975 (Real Volume 294, page 24). Carmen R.  
Crim, Sr. and wife, Helen L. Crim conveyed this tract to Carmen R. Crim Jr.  
and wife, Mary Katherine Crim March 23, 1983 (Real Volume 345, page 853).

This property has remained idle during the periods of time stated.  
The respective owners have had the land surveyed, their corners marked and  
paid the taxes on this property when due.

To my knowledge the above described land has been in open,  
exclusive, notorious, hostile and continuous possession of the above named  
owners during the last 20 years.

To my knowledge this land is recognized in the community and  
generally understood to be the property of the owners named above during  
the periods stated and I have never heard of their title or right of  
possession being questioned or disputed during the past 20 years.
