VERIFIED STATEMENT OF MECHANIC'S AND MATERIALMAN'S LIEN

Ivey Electrical Corporation files this statement in writing, verified by the oath of Tony Bailey, who has personal knowledge of the facts herein set forth:

1. That Ivey Electrical Corporation claims a lien upon the following property, situated in Shelby County, Alabama, said property being the methane gas wells described on Exhibit "A" attached hereto, the Oil, Gas and Methane Gas Leases and leasehold interests making up the production unit for each of the said methane gas wells, all electrical transformers, pump panels, meter stations, fittings and other electrical equipment associated with said methane gas wells, and all other surface equipment, downhole equipment, production equipment, gas gathering lines and any other fixtures and/or equipment located on or associated with the methane gas wells described on Exhibit "A", attached hereto.
2. Pursuant to Section 35-11-217, Code of Alabama (1975) the said Ivey Electrical Corporation also claims a lien against one acre of land being contiguous with one of the said wells described on Exhibit "A", attached hereto. Said one acre is more particularly described as:

One acre in the shape of a square, the center of which is located 1824 feet FEL and 2314 feet FSL of Sec. 34, T21S, R4W, in Shelby County, Alabama, said acre being located in the NW/4 of the SE/4 of said Sec. 34.

3. This lien is claimed, separately and severally, as to the wells and the related surface and production equipment, the leasehold interests, and the electrical equipment owned by McKenzie Methane Corporation and/or Pilgreen Producing Company, their successors and assigns, in the above described property.

4. Said lien is claimed to secure an indebtedness of \$519,639.60, plus interest from the due date of each invoice, for labor done, and materials and supplies furnished by Ivey Electrical Corporation, in connection with the methane gas wells described on Exhibit "A", attached hereto. All of said labor, materials and supplies were furnished by Ivey Electrical Corporation for McKenzie Methane Corporation and/or Pilgreen Producing Company.
