## HORTGAGE SUBORDINATION

WHEREAS, RICHARD L. TRUEB and wife, MOLLY S. TRUEB, (hereinafter called "Mortgagors"), executed a Mortgage covering the hereinafter described real estate (hereinafter called the "AmSouth Mortgage") to the undersigned AmSouth Bank, M.A., a national banking corporation, (hereinafter called the "Mortgagee") to secure the payment of the indebtedness referred to in the Mortgage which was recorded in Book 321, page 177 in the Probate Office of Shelby County, Alabama:

Lot 28, in Block 2, according to the Amended Survey of Woodford, a Subdivision of Inverness, as recorded in Map Book 8, Page 51 A, 8, C and D, in the Probate Office of Shelby County, Alabama.

WHEREAS, the Mortgagors are planning to borrow money from COLLATERAL MORTGAGE, LTD. (hereinafter called "COLLATERAL") which loan or loans is to be secured by a mortgage on the above described real estate (hereinafter called "Real Estate") and, as one of the conditions to COLLATERAL making said loan or loans to the Mortgagors, COLLATERAL has required that the AmSouth Mortgage be subordinated to the mortgage to be executed in favor of COLLATERAL (said mortgage being hereinafter called "COLLATERAL Mortgage"); and

WHEREAS, to induce COLLATERAL to lend money to the Mortgagors upon such terms and conditions, and in such amount

as may be agreed upon by the Mortgagors and COLLATERAL and to induce COLLATERAL, to provide long-term financing in such amount and upon such terms and conditions as may be agreed upon by the Mortgagors and COLLATERAL, the Mortgagee has agreed to subordinate the AmSouth Mortgage to the COLLATERAL Mortgage.

NOW, THEREFORE, in consideration of the presses and \$10.00 in hand paid by COLLATERAL to the Mortgages, the receipt and sufficiency of which is hereby acknowledged by the Mortgages, and to induce COLLATERAL to lend money to the Mortgagors upon such terms and conditions and in such amount as may be agreed upon by the Mortgagors and COLLATERAL, it is hereby agreed as follows:

(1) The Mortgagee, who is now the owner of the AmSouth Mortgage does hereby consent and agree that the AmSouth Mortgage and the lien thereof, and the Mortgagee's rights, title and interest in and to the Real Estate, are and shall be, subject and subordinate to (a) the COLLATERAL Mortgage and to all of COLLATERAL'S rights, title and interest thereunder. It is understood and agreed by the Mortgagee that the AmSouth Mortgage shall be subject and subordinate to the COLLATERAL Mortgage and to all the advances and debts secured thereby. agrees to execute any such additional Mortgagee The instruments which COLLATERAL may request to evidence the subordination of the AmSouth Mortgage to the COLLATERAL Except with respect to this subordination, the Mortgage.

AmSouth Mortgage and the indebtedness secured thereby shall remain in full force and effect.

- (2) Mortgagee does further consent to Mortgagors' execution of the COLLATERAL Mortgage and does agree that the execution of the COLLATERAL Mortgage shall not constitute a sale, transfer, assignment or conveyance within the prohibition of AmSouth or constitute a default of AmSouth.
- (3) This agreement shall be binding upon the successors and assigns of the Mortgages.
