DURABLE POWER OF ATTORNEY

KNOW ALL MEN BY THESE PRESENTS: That I, CYNTHIA BURCH BELYEU, of Birmingham, Shelby County, Alabama, ~~Being over the~~ age of nineteen (19) years, and being of sound mind and disposing memory, do hereby nominate, constitute and appoint JAMES W. BELYEU as my attorney-in-fact, and this Power of Attorney shall become effective immediately and shall continue through any disability, incompetency, or incapacity that I may have and shall otherwise remain in full force and effect until revoked by me or it otherwise terminates by operation of law. As my true and lawful attorney, I do hereby authorize and empower the said JAMES W. BELYEU to act in my behalf and to do all things as follows:

Ask, demand, sue for, collect, recover and receive all sums of money, debts, accounts, interest, dividends, annuities, owing, payable or belonging to me, directly, indirectly, by, through or according to any power of appointment, as beneficiary or by any other means, manner or description.

Make, do and transact all and every kind of business of whatever nature that he considers necessary or that otherwise may arise, and to execute any and all documents necessary therefor and to enter into any agreements or contracts necessary. To do and transact all of my affairs, business or personal, to draw checks on my bank account or accounts, to endorse checks or drafts in my name, to do all things necessary concerning any savings or checking account and any and all other accounts that may be in any banks, credit unions, savings and loan associations and any and all other financial institutions; and further to make deposits to any said accounts and to otherwise perform any and all other banking or financial functions.

Make, seal and deliver, bargain, contract, agree for, buy, sell, mortgage, hypothecate and in any and every way and manner deal in and with goods and personal property and any other property, fixtures or otherwise, in possession or in action.

Bargain, contract, agree for, purchase, receive and take lands, and real property, tenements, hereditaments and accept the seizen and possession of all lands and deeds, lease, bargain, sell (release and satisfy mortgages), release and make satisfactions of other liens, judgment or other encumbrances, convey, mortgage and hypothecate real property, tenements, hereditaments, upon such terms and conditions, and under such covenants as he shall deem advisable.

I hereby give and grant unto my attorney-in-fact full power and authority to do and perform all and every act and thing whatsoever requisite, necessary and/or advisable to be done in and about the premises (including but not limited to the specific powers granted herein), as fully and to all intent and purposes as I might or could do if personally present or able.

Further, I do nominate by this Durable Power of Attorney JAMES W. BELYEU to be my guardian in the event of my disability, incompetency or incapacity. In the event court proceedings become necessary to appoint a guardian, it is my wish

and desire that the within named persons be appointed by the court.

I hereby ratify and confirm all that my attorney-in-fact, as my true and lawful attorney, shall do or cause to be done by virtue of these presents.
