W I T N E S S E T H:

WHEREAS, it has been found to provide water service to
certain areas lying within the City of Columbiana service
area, Shelby County, Alabama; that it has been found
necessary to cross certain lands owned by the Grantors for
the purpose of installing water lines, and other such
integral parts of the water service utility;

WHEREAS, it has been found advantageous and to the best
interest of Grantors and Grantee that an easement for such
water service utility be conveyed to the City of Columbiana.

BOOK THEREFORE, in consideration of the sum of \$ 500.00
and the mutual benefits accruing to the Grantors and to the
City of Columbiana, Shelby County, Alabama, the Grantors
have this day bargained and conveyed and by these presents
do hereby grant and convey unto the City of Columbiana,
Shelby County, Alabama, the following right, privilege and
easement, in, to, along, over, through, under and across the
hereinafter described lands:

The right and privilege to construct, erect,
install, operate and maintain a waterline
on, upon, along, over, through, under and across
the hereinafter described lands;

The right, privilege and easement to cut,
trim and remove any brush, trees, or other
obstructions upon the hereinafter described
lands, together with the right of ingress
and egress to and from, over and above the
hereinafter described lands, for the purpose
of the installation and upkeep of the
waterline.

A 10' wide permanent easement lying within
Parcel 25, Shelby County, Alabama the North
line of which is described as follows:
Commence at the intersection of the Southwest
Right of Way Line of Depot Street with the
Northwest Right of Way Line of Norfolk
Southern Railroad; thence run Southwesterly

along said Northwest Railroad Right of Way a distance of 580' more or less to the point of beginning at the Northwest Corner of the Railroad Right of Way; thence run westerly on a curve arcing to the right (as shown on attached drawing) a distance of 70' more or less to the point of ending on An Alabama Power Company Easement.

Parcel 25 is shown on Shelby County, Alabama Tax Map No. 58-21-0726-2-001.

TO HAVE AND TO HOLD the above described right, privilege, and easement unto the City of Columbiana and to its assigns, together with the right of entry and reentry from time to time as occasion may require for the purpose of exercising its said right, privilege and easement, hereinabove described.

Koenig express or implied, except that there are no liens or encumbrances outstanding against the premises conveyed which were created or suffered by the undersigned and not specifically excepted herein.
