LAST WILL and TESTAMENT

I KNOW ALL MEN BY THESE PRESENTS: THAT I, ROBERT PAUL THOMPSON OF THE TOWN OF STERRETT COUNTY OF SHELBY AND STATE OF ALABAMA BEING OF SOUND AND DISPOSING MIND AND MEMORY, DO MAKE, PUBLISH AND DECLARE THE FOLLOWING TO BE MY LAST WILL AND TESTAMENT, HEREBY REVOKING ALL WILLS BY ME AT ANY TIME HERETOFORE MADE.

FIRST: I DIRECT MY EXECUTRIX, HEREINAFTER NAMED, TO PAY ALL OF MY FUNERAL EXPENSES, ADMINISTRATION EXPENSES OF MY ESTATE AND LIVING INHERITANCE AND SUCCESSION TAXES, STATE OR FEDERAL, WHICH MAY BE OCCASIONED BY THE PASSAGE OF MY SUCCESSION TO ANY INTEREST IN MY ESTATE UNDER THE TERMS OF EITHER THIS INSTRUMENT OR A SEPARATE INTER VIVOS TRUST INSTRUMENT, AND ALL MY JUST DEBTS EXCEPTING MORTGAGE LOANS SECURED BY MORTGAGES UPON REAL ESTATE.

SECOND: ALL THE REST, RESIDUE AND REMAINDER OF MY ESTATE, BOTH REAL AND PERSONAL, OF WHATSOEVER KIND OR CHARACTER, AND WHEREVER SITUATED, I GIVE, DEVISE AND BEQUEATH TO MY BELOVED WIFE,

LILLEA INEZ THOMPSON, TO BE HERS ABSOLUTELY AND FOREVER.

THIRD: IF MY BELOVED WIFE DOES NOT SURVIVE ME, I DIRECT THAT THE REST, RESIDUE AND REMAINDER OF MY ESTATE SHALL BE DIVIDED IN TWO (2) EQUAL PARTS, AND I GIVE, DEVISE AND BEQUEATH ONE OF SUCH PARTS TO EACH OF THE FOLLOWING TWO (2) PERSONS, TO BE HIS ABSOLUTELY AND FOREVER,

KNOW ALL MEN BY THESE PRESENTS: THAT I, LILLEA INEZ FORD THOMPSON OF THE TOWN OF STERRETT COUNTY OF SHELBY AND STATE OF ALABAMA, BEING OF SOUND AND DISPOSING MIND AND MEMORY, DO MAKE, PUBLISH AND DECLARE THE FOLLOWING TO BE MY LAST WILL AND TESTAMENT, HEREBY REVOKING ALL WILLS BY ME AT ANY TIME HERETOFORE MADE.

FIRST: I DIRECT MY EXECUTOR, HEREINAFTER NAMED, TO PAY ALL OF MY FUNERAL EXPENSES, ADMINISTRATION EXPENSES OF MY ESTATE, INCLUDING INHERITANCE AND SUCCESSION TAXES, STATE OR FEDERAL, WHICH MAY BE OCCASIONED BY THE PASSAGE OF OR SUCCESSION TO ANY INTEREST IN MY ESTATE UNDER THE TERMS OF EITHER THIS INSTRUMENT OR A SEPARATE INTER VIVOS TRUST INSTRUMENT, AND ALL MY JUST DEBTS, EXCEPTING MORTGAGES NOTED SECURED BY MORTGAGES UPON REAL ESTATE.
