thence run South 89 degrees 51 minutes 14 seconds East along the South
line of said Section for a distance of 1,341.69 feet to the North-
easterly right-of-way of U.S. Highway #31; thence run North 21 degrees
14 minutes 16 seconds West along said right-of-way for a distance of
374.52 feet to the point of beginning of a curve to the right having
a central angle of 12 degrees 43 minutes 30 seconds, a radius of 2,730.14
feet, and a chord bearing of North 14 degrees 54 minutes 29 seconds West;
thence run along the arc of said curve and said right-of-way for a
distance of 606.35 feet to the end of said curve; thence run North 08
degrees 32 minutes 44 seconds West along said right-of-way for a distance
of 274.22 feet to the point of beginning; thence continue along the last
described course for a distance of 219.81 feet to the point of beginning
of a curve to the left having a central angle of 04 degrees 36 minutes
47 seconds, a radius of 2,859.05 feet, and a chord bearing of North 10
degrees 51 minutes 16 seconds West; thence run along the arc of said
curve for a distance of 230.19 feet; thence leaving said right-of-way
run South 90 degrees East for a distance of 430.57 feet; thence run
South 00 degrees 39 minutes 24 seconds West for a distance of 379.09
feet; thence run South 79 degrees 35 minutes 39 seconds West for a
distance of 356.08 feet to the point of beginning. Situated in Shelby
