
ARTICLES OF INCORPORATION
OF

The undersigned, acting as incorporator of a corporation under the Revised Alabama Professional Corporation Act, adopts the following Articles of Incorporation for such corporation:

FIRST: The name of the corporation is Metro Cat Clinic, P.C.

SECOND: The period of its duration is perpetual.

THIRD: The purpose or purposes for which the corporation is organized are as follows: (i) to engage in all aspects of the practice of veterinary medicine; (ii) to invest its funds in real estate, mortgages, stocks, bonds, and other types of investments to the extent permitted by the Revised Alabama Professional Corporation Act; and (iii) to transact such other business as may be permitted by the Revised Alabama Professional Corporation Act.

FOURTH: The aggregate number of shares which the corporation shall have authority to issue is 1,000 shares of common stock, having a par value of \$1.00 per share.

FIFTH: The address of the initial registered office of the corporation is 2080 Valleydale Road, Hoover, Alabama 35244, and the name of its initial registered agent at such address is J. M. Openshaw.
