WHEREAS, America's First Credit Union, formerly doing business as Iron and Steel Workers Credit Union, a corporation, was put into conservatorship by the National Credit Union Administration, whereas the Board of Directors was replaced with a National Credit Union Administration Conservatorship Advisory Committee and whereas, this committee met on June 27, 1991, in accordance with the authority and power granted by the National Credit Union Administration, the committee unanimously adopted and passed the following resolution:

"Resolved, that either Linda Connelly, acting President or Sam L. Brown are hereby appointed as attorney in fact for the said Credit Union with authorization and power to mark or stamp paid on the margin of the record of any and all mortgages held by America's First Credit Union, formerly doing business as Iron and Steel Workers Credit Union, a corporation, execute partial and full releases of real estate mortgages and do any and all other things necessary and proper to be done in order to satisfy mortgages and execute partial releases and be it further resolved that the certain instrument recorded at Volume 1165, Page 501, in the Probate Office of Jefferson County, Alabama, and that certain instrument recorded at Volume 247, Page 154, in the Bessemer Division of the Probate Office of Jefferson County, Alabama are hereby revoked and annulled effective July 10, 1991."
