(2) To appoint special Attorneys-in-fact (who are hereby authorized to certify to copies of any power of attorney issued in pursuance of this section and/or any of the By-Laws of the Company, and)

(3) To remove at any time, any such Attorney-in-fact or Special Attorney-in-fact and revoke the authority given him.

Further, this Power of Attorney is signed and sealed by facsimile pursuant to resolution of the Board of Directors of said Company adopted at a meeting called and held on the 5th day of May, 1989, at which the following is a true ex-

ecution of the signatures of such officers and the seal of the Company. They may be affixed to any such power of attorney or any certificate relating

thereto by facsimile; and any such power of attorney or certificate bearing such facsimile signatures or facsimile seal shall be valid and binding upon the Company and any such power so executed and certified by facsimile signatures and facsimile seal shall be valid and binding upon the Company in the future with respect to any bond or undertaking to which it is attached.
