Honeycutt, individually, and as Trustees of the Last Will & Testament of Tom Lee, deceased (herein referred to as grantors), grant, bargain, sell and convey unto Robert E. Lee (herein referred to as grantee), the following described real estate, situated in Shelby County, Alabama, to-wit:

PARCEL E:

Commence at the SE corner of the NW 1/4 of SE 1/4, Section 12, Township 20 South, Range 3 West; thence N 89 deg. 53' 05" W and run 900.88 feet along 1/4 1/4 line; thence N 25 deg. 49' 04" E and run 391.6 feet; thence N 64 deg. 10' 56" W and run 375.0 feet; thence N 25 deg. 49' 04" E and run 120.0 feet to the point of beginning; thence N 64 deg. 10' 56" W and run 225.0 feet; thence N 25 deg. 49' 04" E and run 90.0 feet; thence S 64 deg. 10' 56" E and run 255.0 feet; thence S 25 deg. 49' 04" W and run 90.0 feet; thence N 64 deg. 10' 56" W and run 30 feet to the point of beginning.
