AMENDMENT TO ARTICLES OF INCORPORATION
OF

The Articles of Incorporation of Clark Corporation are hereby amended pursuant to the provisions of Section 10-2A-113, Code of Alabama, 1975, as amended, in accordance with these articles of amendment.

1. The name of the corporation is: CLARK CORPORATION.
2. The amendment to the articles of incorporation of CLARK CORPORATION are as follows:

THE AUTHORIZED CAPITAL IS INCREASED FROM \$30,000 TO \$31,250; THE AUTHORIZED NUMBER OF SHARES OF STOCK SHALL BE INCREASED FROM 30,000 AT \$1.00 PAR VALUE EACH TO 31,250 SHARES AT PAR VALUE OF \$1.00 EACH.

All other provisions of the original articles of incorporation not in conflict herewith shall remain in full force and effect.

3. The foregoing amendments were adopted by the board of directors and approved by the shareholders on August 19, 1991.
4. The number of shares outstanding and the number of shares entitled to vote in such amendment is 30,000 shares.
5. The number of shares voting in favor and approving of such amendment was 30,000 shares. No votes were cast in opposition to such amendment.
