A part of the West 1/2 of the Southeast 1/4 of the Southeast 1/4 of Section 30, Township 21 South, Range 1 East, Shelby County, Alabama, said parcel being more particularly described as follows:

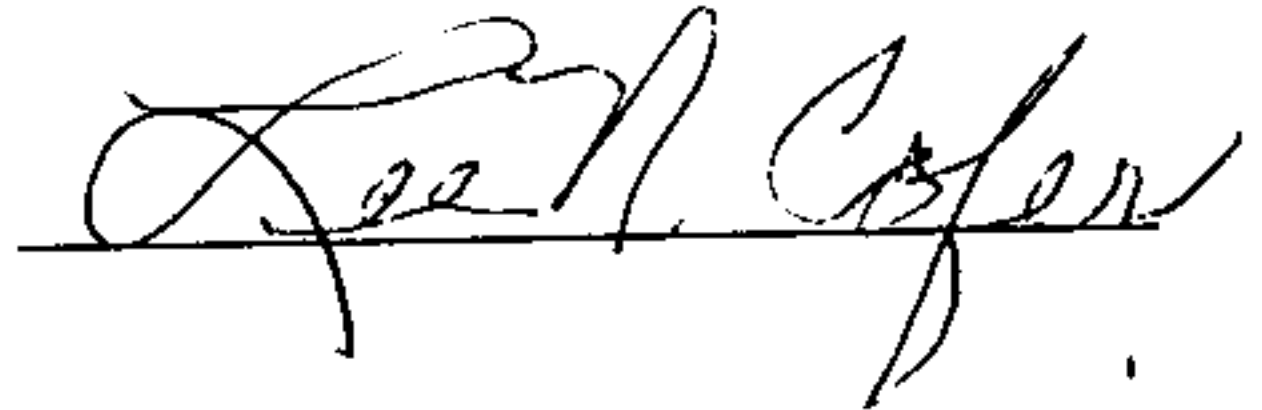
