I will obtain hazard insurance to cover all buildings and other improvements that now are or in the future will be located on the Property. The insurance must cover loss or damage caused by fire, hazards normally covered by "extended coverage" hazard insurance policies, and other hazards for which Lender requires coverage. The insurance must be in the amounts and for the periods of time required by Lender, Lender may not require me to obtain an amount of

coverage that is more than the value of all buildings and other improvements on the Property. I may choose the insurance company, but my choice is subject to Lender's approval. S. BORROWER'S OBLIGATION TO MAINTAIN THE PROPERTY AND TO FULFILL OBLIGATIONS IN LEASE, AND AGREEMENTS ABOUT CONDOMINIUMS

(A) Agreements about Maintaining the Property and Keeping Promises in Lease I will keep the Property in good repair. I will not destroy or substantially change the Property, and I will not allow the Property to deteriorate. 6. LENDER'S RIGHT TO TAKE ACTION TO PROTECT THE PROPERTY

rights under the law, one at a time or all at once.
