**ARTICLES OF INCORPORATION**  
**OF**

1. The name of the corporation is **Ideal Environments, Inc.**
2. The period of its duration is perpetual.

3. The purpose or purposes for which the corporation is organized are to conduct research and development of systems related to the environmental treatment of waste and related issues; to engage in any lawful business or activities related to the stated purposes; and to engage in any lawful act or activity for which corporations may be organized under the Alabama Business Corporations Act.

4. The aggregate number of shares of capital stock which the corporation shall have authority to issue is 10,000 shares of common stock, par value of \$1.00 per share.

5. The location and mailing address of the initial registered office of the corporation is 136 8th Street S.W., Alabaster, Shelby County, Alabama 35007 and the name of its initial registered agent at this address is Jim C. Bratton.

6. The number of directors constituting the initial board of directors of the corporation is one, and the name and address of the person who is to serve as director until the first annual meeting of shareholders and until his successors are elected and shall qualify is as follows:

8. Each shareholder shall have a pre-emptive right to purchase shares of any class of capital stock of the corporation, including treasury shares.

The corporation shall have the right to purchase, take, receive or otherwise acquire, hold, own, pledge and transfer or otherwise acquire, hold, own, pledge and transfer or otherwise dispose of its own shares. Purchases by the corporation of its own shares, whether direct or indirect, may be made to the extent of unreserved and unrestricted earned surplus and capital surplus of the corporation available therefor.

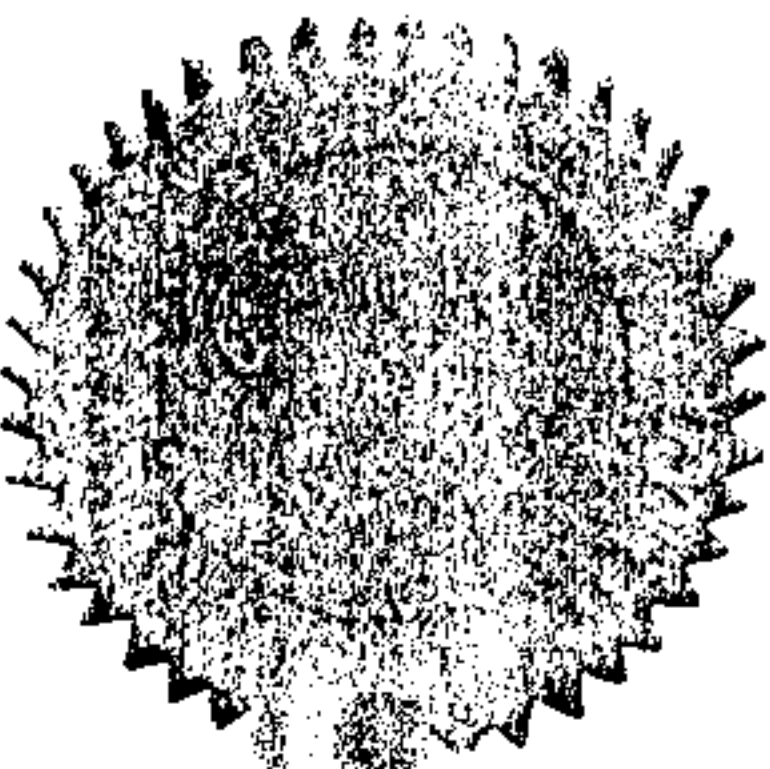
