A judgment for the plaintiff is hereby entered against defendant, DeMarco Concrete Block Company, Inc..

Judgment against all defendants is as follows:

1) Alice Frances Dunham a/k/a Alice Frances Dunnam f/k/a Alice Frances Bailey owns in fee simple and is entitled to the quiet and peaceful possession of that real property situated in the County of Shelby, State of Alabama, and described as follows:

A part of the SW 1/4 of the NE 1/4 of Section 20, Township 21, Range 2 West, more particularly described as follows: Commencing at the Northwest corner of the SW 1/4 of the NE 1/4 of said Section 20 and run South 31 degrees 20' East 366 feet; thence run South 24 degrees 50' East 361 feet to a point of beginning of tract herein described; thence run North 78 degrees 49' East 459.9 feet along the North side of Newton property to the West right of way line of the Birmingham-Montgomery Highway; thence along the West right of way line of said Highway North 28 degrees 20' West 200 feet to the SE corner of Bailey lot; thence run South 71 degrees 40' West 438 feet; thence run South 24 degrees 50' East 136 feet to point of beginning.

2) Defendants' claim to said property is without any right whatever and defendants have no estate, right, title, lien, or interest in or to said property or any part thereof.
