Together with all the rights, privileges, tenements, and appurtenances thereunto belonging or in any wise appertaining, including screen wandows and doors, gas, steam, electric and other heating, lighting and cooking apparatus, elevators, ice boxes, plumbing and other fixtures appertaining to the said premises, all of which shall be deemed realty and conveyed by this mortgage.
