EXHIBIT "A"
LEGAL DESCRIPTION

Commence at the back of the curb on the East side of Line Street, and the back of the side-walk on the South side of Kingdom Road, thence run East along the back of the side-walk a distance of 86.63 feet; thence turn a deflection angle of 1 deg. 01 min. 04 sec. to the right and continue along the back of the side-walk a distance of 64.16 feet; thence turn a deflection angle of 1 deg. 15 min. 54 sec. to the right and continue along the back of the side-walk, a distance of 46.04 feet; thence turn a deflection angle of 1 deg. 15 min. 07 sec. to the right and continue along the back of the side-walk a distance of 155.00 feet; thence turn a deflection angle of 90 deg. 52 min. 00 sec. to the right and run a distance of 26.11 feet; thence turn a deflection angle of 91 deg. 20 min. 39 sec. to the left and run along the South right of way of Shelby County Highway No. 28, known as Kingdom Road, a distance of 63.78 feet, to the point of beginning; thence continue along said Highway right of way a distance of 58.88 feet, to the P.C. of a right of way curve; thence run along said right of way curve (whose Delta Angle is 53 deg. 18 min. 18 sec. to the right, Radius is 676.78 feet, Tangent is 339.68 feet, Length of Arc is 629.64 feet); thence turn a deflection angle of 65 deg. 21 min. 19 sec. to the right from the Tangent of said curve and run a distance of 286.79 feet; thence turn a deflection angle of 64 deg. 27 min. 22 sec. to the right and run a distance of 426.41 feet; thence turn a deflection angle of 2 deg. 48 min. 03 sec. to the right and run a distance of 107.51 feet; thence turn a deflection angle of 92 deg. 48 min. 33 sec. to the right and run a distance of 138.23 feet; thence turn a deflection angle of 1 deg. 01 min. 26 sec. to the left and run a distance of 356.32 feet, to the point of beginning. Situated in the Northwest 1/4 of the Northeast 1/4 and the Northeast 1/4 of the Northwest 1/4, Section 25, Township 21 South, Range 1 West, Shelby County, Alabama; being situated in Shelby County, Alabama.
