bargained and sold, and by these presents do hereby grant, bargain, sell and

convey unto the State of Alabama the following described property, lying and

being in SHELBY County, Alabama, and more particularly

described as follows: and as shown on the right-of-way map of Project No. S-44(8) of record in the State of Alabama Highway Department, a copy of which is also deposited in the Office of the Judge of Probate of Shelby County, Alabama as an aid to persons and entities interested therein and as shown on the Property Plat attached hereto and made a part hereof:

Commencing at the northeast corner of the SW1 of NE1, Section 3, T-24-N, R-12-E; thence westerly along the north line of said SW1 of NE1, a distance of 250 feet, more or less, to the east property line; thence southerly along said east property line, a distance of 300 feet, more or less, to a point that is 45 feet northeasterly of and at right angles to the centerline of Project No. S-44(8) and the point of beginning of the property herein to be conveyed; thence continuing southerly along said east line, a distance of 14 feet, more or less, to the present northeast right-of-way line of Alabama Highway No. 25; thence northwesterly along said present northeast right-of-way line, a distance of 270 feet, more or less, to the west property line; thence northerly along said west line, a distance of 14 feet, more or less, to a point that is 45 feet northeasterly of and at right angles to the centerline of said project; thence S 84° 18' 28" E, parallel with the centerline of said project, a distance of 268 feet, more or less, to the point of beginning.


