**CERTIFICATE OF SECOND AMENDMENT**  
**TO**  
**AGREEMENT AND CERTIFICATE OF LIMITED PARTNERSHIP**

Pursuant to Ala. Code § 10-9A-21 the undersigned general and limited partners of CSR, Ltd. (the "Partnership"), an Alabama limited partnership organized and existing pursuant to an Agreement and Certificate of Limited Partnership (the "Partnership Agreement") recorded in Book 29, page 891, in the Office of the Judge of Probate of Shelby County, Alabama, as amended by Certificate of First Amendment recorded in Book 044, page 35, in said office, do hereby certify and agree to the following additional amendment to the Partnership Agreement:

**ARTICLE I**

The name of the Partnership is: CSR, LTD.

**ARTICLE II**

The date of filing of the Partnership Agreement was March 11, 1986 and the Certificate of First Amendment thereto was filed on April 22, 1991.

**ARTICLE III**

The 20% limited partnership interest in the partnership heretofore owned by Central Steel Service, Inc., an Alabama corporation, was transferred and assigned by said corporation to its stockholders (the other general and limited partners in the Partnership) as a dividend in kind effective September 30, 1991. Accordingly, Article VI of the Partnership Agreement is hereby amended effective as of September 30, 1991, to read as follows:
