O R D E R

This matter is before the Court on a motion filed by the trustee, Bob Rodgers, to confirm the sale of three pieces of property belonging to the debtor, Sam Amselma Fiorella. The hearing in this matter was held on the 14th day of August, 1991.

No opposition having appeared, the Court is of the opinion that the sale of the three pieces of property is due to be confirmed. The Court finds that all valid liens shall attach to the proceeds derived from the sale of these properties.

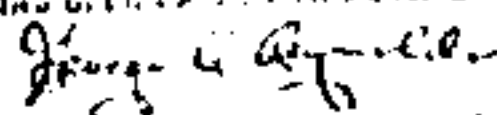

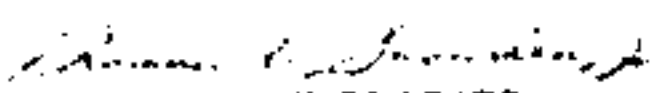
