RELEASE AND SATISFACTION OF MORTGAGE INDENTURE

WHEREAS, heretofore on the first day of February, 1979, The Industrial Development Board of the Town of Pelham, a public corporation (the "Board"), issued certain industrial development revenue bonds for the purpose of acquiring title to certain real property located in Shelby County, Alabama, and constructing and equipping thereon a facility and certain improvements (the "Bond Issue"); and

WHEREAS, to secure the payment of said Bond Issue, the Board executed a mortgage and indenture of trust to First Alabama Bank of Birmingham (now known as First Alabama Bank) (the "Bank"), which mortgage and indenture of trust was duly recorded in the Probate Office of Shelby County, Alabama, in Real Volume 388, Page 767, as supplemented by that certain Supplemental Indenture of Trust recorded in Real Volume 30, Page 194, in the Probate Office of Shelby County, Alabama (hereinafter referred to as the "Mortgage Indenture"); and

WHEREAS, the revenue bonds under the Bond Issue have now been paid in full; and

WHEREAS, the Bank now desires to release all of the property described in the Mortgage Indenture and to declare the lien of the Mortgage Indenture paid in full.

NOW, THEREFORE, in consideration of the sum of One and No/100 Dollars (\$1.00) and other good and valuable considerations, the undersigned, First Alabama Bank of Birmingham (now known as First Alabama Bank), does hereby acknowledge full payment of the Bond Issue secured by the Mortgage Indenture and does hereby further release and satisfy said Mortgage Indenture and releases and discharges from the lien of the Mortgage Indenture all property described therein.
