Know all men by these presents, that in consideration of mutual covenants and agreements, constituting good and valuable consideration to the undersigned grantor, the Board of Education of Shelby County Alabama, in hand paid by the grantee herein, the receipt of which is hereby acknowledged, the Board of Education of Shelby County Alabama does grant, bargain, sell, and convey unto the City of Montevallo, Alabama, a municipal corporation, of 545 Main Street, Montevallo, AL 35115 (herein referred to as grantee, whether one or more) the following described real estate situated in Shelby County, Alabama, to-wit:

A parcel of land situated in the City of Montevallo in the E½ of the SW¼ of §21, Twp 22S, R3W being more particularly described as follows: Commence at the NE corner of Lot 14, Storr's and Troy's Addition to Montevallo, as recorded in Map Book 3, page 3 in the office of the Judge of Probate of Shelby County, Alabama, and run in a southerly direction along the westerly line of said Lot 14 for 101.42 feet to the SW corner of said Lot 14, thence turn an angle of 90°00' to the right and run southwesterly 25 feet to a point in the centerline of Island Street; thence turn an angle of 90° to the left and run southeasterly along the centerline of Island Street for 100.23 feet; thence turn 70°28'08" to the right and run southwesterly for 26.53 feet to the point of beginning of the parcel herein described; thence turn 90° to the left and run southeasterly for 20 feet; thence turn 90° to the right and run southwesterly for 219.52 feet to the point of curve of a curve to the left; thence in the arc of said curve, having a radius of 356.35 feet and a central angle of 15°08'08" for 94.14 feet to the point of tangent of said curve; thence in the tangent to said curve southwesterly for 262.46 feet to a point; thence turn 97° to the right and run northwesterly for 40.30 feet; thence turn 83° to the right and run northeasterly for 257.54 feet to the point of curve of a curve to the right, thence in the arc of said curve, having a radius of 396.35 feet and a central angle of 5°08'08" for 104.70 feet to the point of tangent of said curve; thence in that tangent to said curve northeasterly for 216.02 feet to the point of curve of a curve to the left; thence in the arc of said curve, having a radius of 15 feet and a central angle of 80°28'08" for 18.45 feet to the point of tangent of said curve; thence turn 180° to the right and run southeasterly for 31.81 feet to the point of beginning.
