CHURCH, Birmingham, Alabama, a non-profit corporation, from the lien and operation of that certain Mortgage in favor of BIRMINGHAM BAPTIST ASSOCIATION, filed for record April 19, 1976, in Volume 392, Page 32, Amended by Volume 392, Page 36, in the Probate Office of Shelby County, Texas, securing the following described real estate situated in the County of Shelby, State of Alabama, to-wit:

Commence at the Northwest corner of NE 1/4 - SE 1/4 of Section 16, Township 19 South, Range 2 West, and run Southeasterly along diagonal line of the Northeast Quarter of Southeast Quarter for a distance of 349.87 feet to the South side of Valley Dale Road; thence 115° 07' to the right in a Southwesterly direction along said South line of said road for a distance of 458.83 feet to the point of a curve to the left having a radius of 908.22 feet; thence along the arc of said curve a distance of 604.61 feet to the point of beginning of parcel of land for Kindergarten House; said point being on the southwesterly line of Public Road; thence continue along South line of Valley Dale Road for a distance of 164.5 feet to a point; thence turn 93° 44' to the left and run for a distance of 249 feet to a point; thence turn 92° 57' to the left and run for a distance of 190 feet to a point on the westerly line of Public Road; thence run Northwesterly along said westerly line of said Public Road for a distance of 257.8 feet to the point of beginning.

AND FOR THE SAME consideration, the undersigned does hereby remise, release, quitclaim, and convey unto VALLEYDALE BAPTIST CHURCH, a non-profit corporation, all of its right, title and interest in and to said tracts or parcels of land hereinabove described.
