

ARTICLES OF DISSOLUTION

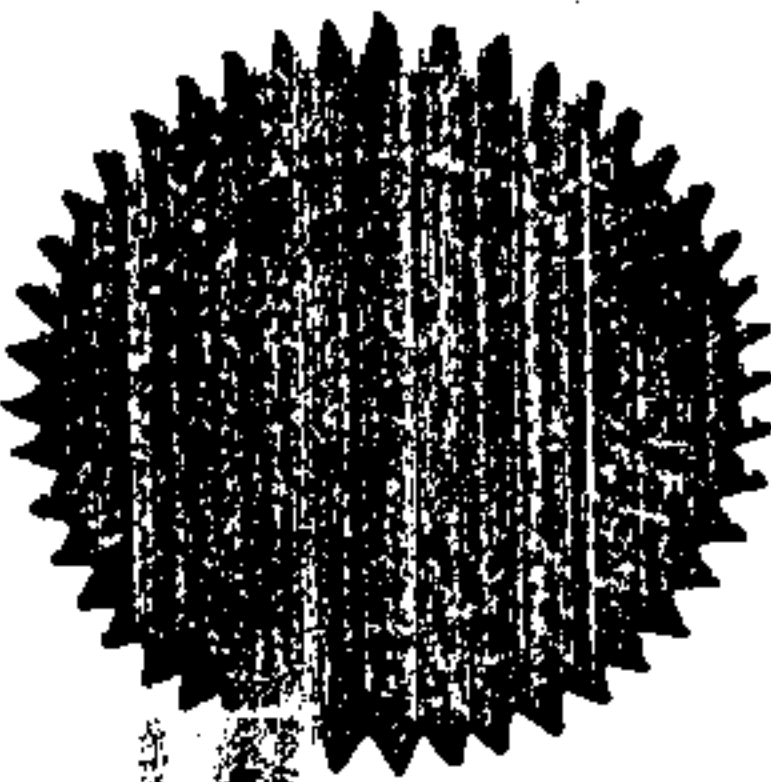
