Comes now the undersigned Affiants and sayeth as follows:

That WHEREAS 10 days notice of a meeting of the CHURCH OF GOD AT ALABASTER (a/k/a ALABASTER CHURCH OF GOD) was given in strict accordance with the Local and State By-Laws of the Church and that the meeting was called for the purpose of borrowing monies from JUANITA F. WOODS in the sum of One Hundred Eighty Thousand and No/hundred Dollars (\$180,000.00). That said sum being borrowed to; (1) pay off that certain Mortgage held by the First National Bank of Columbiana dated August 21, 1991; (2) pay off outstanding loan from the Church of God State Office for \$10,000.00; (3) Cover miscellaneous expenses associated with the new building for the use and benefit of the Local Church. (See Exhibit "A" attached hereto to become part hereof.)

That WHEREAS the General Assembly of the Church of God is the organized body with full power and authority to designated and govern the operations of the Church of God AND the General Assembly has vested in the office of the state overseer authority over the local churches.

That WHEREAS the Minutes and By-laws of the Governing

body specifically state that the Local Board of Trustees shall hold title to, manage, and control, pursuant to the direction of the local congregation by which they are selected, provided that all such property shall be used, managed, and controlled for the sole and exclusive use and benefit of the Church of God, Cleveland, Tennessee, U.S.A. And that the Church of God at Alabaster holds title to property for the sole and exclusive use and benefit of the Church of God, Cleveland, Tennessee, U.S.A. That said property is as described in Exhibit "B" attached hereto, and made a part hereof. That in accordance with the Minutes and By-laws of the Church of God each local church or congregation that owns any real estate, shall appoint a Local Board of Trustee, to consist of not less than three (3) members, and such Local Board of Trustees shall have full right, power, and authority to buy property for the use or benefit of the local congregations; sell, hypothecate, exchange, transfer and convey any of the local property held or borrow money and pledge the said property for the repayment of the same and to execute all necessary deeds, conveyances, and so forth, provided the proposition shall first be presented to the regular or called conference of the local church presided over by the state overseer, or one whom he may appoint, and approved by a two-thirds majority vote and provided further that the board have a certification from the state overseer, or one whom he may appoint, that the proposition is not adverse to the interest of the Church of

God.

That WHEREAS we the undersigned sayeth under oath that we, as Trustees and officers of the Church are authorized to proceed with the mortgage of said property as described in Exhibit "A" and we are empowered, authorized and directed to execute any mortgage or other instruments and documents in order to consummate said loan from Juanita F. Woods.

That a vote was held in accordance with the provisions set out for such and that IT WAS RESOLVED by two-thirds vote of the membership of said Church to mortgage said property

AND THEREUPON, a vote was held on said Resolution and such was that no member voted "Nay". Upon computation of the total number of votes, it appeared that all member present voted "AYE" and thereby recommend and empower that the Trustees and other officers proceed to execute a mortgage or any other papers necessary to consummate said loan.

The we the undersigned Trustees sayeth further that the State Overseer for the Church of God in Alabama, GUARANTEES the loan to JUANITA F. WOODS, which said Guarantee is executed under ABSOLUTE CONTINUING GUARANTY for JUANTIA F. WOODS. See Exhibit "C" attached hereto to become part hereof.

FURTHER, that H. Melvin Massey, as Pastor, and Jimmy
Freeman, Steve Cherry and Danny Aultman as Trustee for Church
of God at Alabaster hereby certify that the execution of said

To Whom It May Concern:

A meeting with the men of the Alabaster Church of God was held on September 16, 1990. During this meeting a motion was made to borrow \$200,000.00 for the purpose of consolidating loans and to build a new building. This was passed with a unanimous vote.

A meeting with the entire congregation of the Alabaster Church of God was held on September 30, 1990 to vote whether to borrow the \$200,000.00 mentioned above. This was passed with a majority vote.

A meeting with the men of the Alabaster Church of God was held on December 18, 1991, to decide on the amount of money to be borrowed from Juanita Wood. The loan was to cover three items: 1) payoff current Construction loan in the amount of \$150,000.00 plus interest with First National Bank of Columbiana; 2) payoff outstanding loan from the Church of God state office for \$10,000.00; 3) cover miscellaneous expenses associated with new building. The amount decided upon was \$160,000.00 with a unanimous vote.
