JUDGMENT BY CONSENT

This action came on for hearing before the Court, the Honorable
Stuart Leach, Circuit Judge, presiding, and it having been
represented to the Court that all parties to the action have consented that this cause may
be heard by the Court without further notice to the Defendant{s}, and that judgment may
be rendered against the Defendant{s} as hereinafter provided, and upon hearing the
evidence and reviewing the pleadings in this cause, the Court being of the opinion,

It is hereby **CONSIDERED, ORDERED** and **ADJUDGED** that the plaintiff
Atlantic Steel Company shall have and recover of the Defendant, Curry C. McWhorter the
total sum of \$32,577.50 (representing the principal sum owing to the plaintiff of \$29,500.00,
together with accrued interest through October 31, 1991, equal to \$1,327.50, plus interest
accrued from said date until the date of judgment at a per diem rate of \$14.75), together
with interest accruing thereafter at a rate of one and one-half percent (1 1/2%) per month,

plus attorneys' fees and costs in the amount of \$1,750.00 and for all of which execution may issue.

It is hereby further **CONSIDERED, ORDERED** and **ADJUDGED** that the plaintiff shall, for a period commencing on the date of entry of this judgment and continuing for so long as Defendant Curry C. McWhorter shall comply with the payment schedule set forth below, withhold execution, garnishment or other post-judgment legal process provided by law for the collection of judgments; provided, however, that the foregoing shall not in any way prohibit or impair the plaintiff from perfecting a judgment lien by recording this judgment (or a certificate of this judgment) in any public office.

The payment schedule incorporated to this Judgment shall require the following payments to be made to the Plaintiff:

1. \$6,250.00 on or before December 1, 1991;
2. \$5,000.00 on or before January 1, 1992;
3. \$5,000.00 on or before February 1, 1992;
4. Remaining balance, plus all accrued but unpaid interest, on or before March 1, 1992.
