That in consideration of ONE HUNDRED TWENTY THREE THOUSAND FIVE HUNDRED & NO/100---- (\$123,500.00) DOLLARS to the undersigned grantor or grantors in hand paid by the GRANTEES herein, the receipt whereof is acknowledged, we, David Neal Moore and wife, Constance B. Moore (herein referred to as grantors), do grant, bargain, sell and convey unto Jerry A. Payne and wife, Tammy R.
