ARTICLES OF INCORPORATION OF

(A Close Corporation)

The undersigned, acting as incorporator of a corporation under the Code of Alabama, adopts the following Articles of Incorporation for such corporation:

FIRST: The name of the corporation is: Vending Unlimited, Inc.

SECOND: The period of its duration is perpetual.

THIRD: The purpose or purposes for which the corporation is organized are: To carry on and conduct a vending machine sales and placement business; to execute contracts or receive assignments of contracts therefor, or relating thereto and to transact all lawful business for which corporations may be organized under the Code of Alabama.

FOURTH: The aggregate number of shares which the corporation shall have authority to issue is One Thousand (1000) shares at One Dollar (\$1.00) per share. The corporation shall begin business with and issue One Thousand of said shares of a par value of One Dollar (\$1.00) per share.

ELEVENTH: For purposes of determining the number of holders of record of the stock of the corporation, stock which is held in joint tenancy or common tenancy or by the entireties shall be treated as held by one shareholder.

TWELFTH: All of the corporation's issued shares of all classes, exclusive of treasury shares, shall be held of record by not more than Thirty (30) persons.

The formation of the corporation as a close corporation has been authorized by the affirmative vote of all holders of and subscribers to shares of the corporation.


