AFFIDAVIT

Before me, the undersigned authority, in and for said County and State, personally appeared Mae Frances Chancellor, who, being known to me and being by me first duly sworn, deposes and says as follows:

My name is Mae Frances Chancellor, and I am one of three surviving children of my father, Sam Kelley. I am a widow, and I reside at 528 West Burgess Street, Pittsburgh, Pennsylvania 15214. My father, Sam Kelley, died on April 18, 1957. He was a resident of Wilsonville, Shelby County, Alabama at the time of his death. He was married to my stepmother, Zada Kelley, at the time of his death. My stepmother, Zada Kelley, died April 17, 1991. There were no children born of the marriage of my father, Sam Kelley, to Zada Kelley. Zada Kelley had no children born to her of any other relationship. Zada Kelley's first and only marriage was to my father. She was living in Pittsburgh, Pennsylvania at the time of her death.

My father, Sam Kelley, died without a will. He was the father of eight children. Three of his children, Elbert Frank Kelley, Earline Kelley, and an unnamed child, died in infancy. My brother, J. C. Kelley, died when he was eighteen, and he had no children. My brother, James Kelley, died in 1973. He was not married at the time of his death. His only child, a son, predeceased him.
