DECLARATION OF UNIT

There is hereby pooled and combined, into the area described above, all the leasehold, mineral, overriding royalty and royalty interest and all other interest in the above described units as to which the undersigned (or any of the undersigned) have the right to pool and combine into the units created hereby whether or not said leases and other interests are particularly described herein. Said units are subject to the rules, regulations and orders of the Oil and Gas Board of Alabama, and the above described lands have been established as gas units by Order of the State Oil and Gas Board of Alabama for the KC/SEGCO 31-14-225 well unit and the KC/SEGCO 31-7-652 well unit.
