WARRANTY DEED (With Survivorship)

STATE OF ALABAMA

KNOW ALL MEN BY THESE PRESENTS

COUNTY OF JEFFERSON

That in consideration of One Dollars and 00/100 (\$1.00) ^{500.00} and other valuable considerations to the undersigned grantor(s), Phyllis S. Trotter, a married woman, in hand paid by Phyllis S. Trotter and husband, Kenneth V. Trotter, (hereinafter referred to as grantee(s) the receipt whereof is hereby acknowledged, the said grantor(s) do hereby grant, bargain, sell and convey unto the said grantee(s), as joint tenants, with the right of survivorship, the following described real estate, situated in Shelby County, Alabama, to-wit:

Lot 25, according to the survey of Valley Station, Second Sector, as recorded in Map Book 7, Page 48 in the Probate Office of Shelby County, Alabama.

TO HAVE AND TO HOLD, to the said GRANTEE(S) as joint tenants, with the right of survivorship, their heirs and assigns, forever; it being the intention of the parties to this conveyance, that, unless the joint tenancy hereby created is severed or terminated during the joint lives of the GRANTEES herein, in the event one GRANTEE herein survives the other, the entire interest in fee simple in and to the property described hereinabove shall pass to the surviving GRANTEE, and if on does not survive the other, then the heirs and assigns of the GRANTEES herein shall take as tenants in common.
