## ORDINANCE NO. Ø3-92-01

AN ORDINANCE AMENDING ORDINANCE NO. 353 AS AMENDED BY ORD. NOS. 12-91-04 and 02-92-02 SO AS TO ADJUST THE BOUNDARIES OF VOTING WARDS

BE IT ORDAINED BY THE MAYOR AND COUNCIL OF THE CITY OF COLUMBIANA, ALABAMA, AS FOLLOWS:

Section 1: Pursuant to the provisions of Section 11-46-23, Code of Alabama 1975, as amended, Section 2(c) of Ordinance No. 353 as amended by Ordinance Nos. 12-91-04 and 02-92-02 is further amended so that the legal descriptions of Ward Nos. 4 and 5 read as follows:

"(c) The geographical boundaries of the election wards are hereby established and described as follows:

Ward No. 4. Begin at the intersection of the centerline of Old Highway No. 25 and the centerline of Shelby County
Highway No. 30 and run East along Highway No. 30 to the Eastern
city limit line; then turn right and run along the city limit line
to the centerline of Lynn Drive; then turn right and run along
Lynn Drive to the centerline of Shelby County Highway No. 28;
then turn right and run along Highway No. 28 to the centerline
of East College Street; then turn left and run along East College
Street to the centerline of Milner Street; then turn left and run
along Milner Street to the centerline of Mildred Street; then
turn left and run along Mildred Street to the centerline of
Washington Street; then turn right and run South along Washington

Street and the extension thereof to the centerline of Bolton Lane; then turn right and run along Bolton Lane to the centerline of Pitts Drive; then turn left and run along Pitts Drive to the centerline of Shelby County Highway No. 47, also known as Main Street; then turn right and run North along Highway No. 47 and Main Street to the centerline of West College Street; then turn left and run along West College Street to the centerline of Alabama Gas Corp. right-of-way (formerly railroad rightof-way); then turn right and run along Alabama Gas Corp. right-ofway to the centerline of Butler Street; then run along Butler Street to the centerline of Collins Street; then turn right and run along Collins Street to the centerline of Lauderdale Street; then turn left and run along Lauderdale Street to the centerline of Lester Street; then turn right and run along Lester Street to the centerline of a drainage ditch; then turn left and run along the drainage ditch to the centerline of Shelby County Highway No. 47, also known as Main Street; then turn left and run North along Main Street to the centerline of Meyer Street; then turn right and run along Meyer Street to the centerline of Thompson Street; then turn right and run along Thompson Street to the centerline of Center Street; then turn left and run along Center Street to the centerline of Goodwin Street; then turn right and run along Goodwin Street to the centerline of East College Street, also known as Old Highway No. 25; then turn left and run along Old Highway No. 25 to the point of beginning.

Ward No. 5. Begin at the intersection of the centerline of Shelby County Highway No. 30 and the Easterly city limit line at Alston Farm Road and run West along Highway No. 30 to the centerline of Old Highway No. 25, also known as East College Street; then turn left and run along East College Street to the centerline of Goodwin Street; then turn right and run along Goodwin Street to the centerline of Center Street; then turn left and run along Center Street to the centerline of Thompson Street; then turn right and run along Thompson Street to the centerline of Meyer Street; then turn left and run along Meyer Street to the centerline of Main Street; then turn left and run South along Main Street to the centerline of a drainage ditch; then turn right and run along the drainage ditch to the centerline of Lester Street; then turn right and run along Lester Street to the centerline of Lauderdale Street; then turn left and run along Lauderdale Street to the centerline of Collins Street; then turn right and run along Collins Street to the centerline of West Sterrett Street; then turn left and run along West Street Street to the centerline of Alabama State Highway No. 25; then turn right and run along Highway No. 25 to the centerline of Shelby County Highway No. 47; then turn left and run North along Highway No. 47 to the city limit line at the North line of the SW of SE of Section 14, Township 21 South, Range 1 West; then turn left and run clockwise along the city limit line to the point of beginning."

Section 2. All ordinances and parts of ordinances, heretofore adopted by the City Council of the City of Columbiana, Alabama, which are in conflict with this ordinance, are hereby repealed to the extent of such conflict.

Section 3. (Severability) Each and every provision of this Ordinance is hereby declared to be an independent provision and the holding of any provisions hereof to be void and invalid shall not affect any other provisions of this ordinance.

Section 4. (Effective date) This Ordinance shall become effective upon its passage and adoption by the City Council of the City of Columbiana.
